Updates in the 18.8 Release

Notable New Features:

- Analytics Hub—the Attendance, Assessment, and EMIS folders now contain sub-folders into which ad-hoc reports are grouped. These folders can be collapsed or expanded in an effort to most easily find the report needed.
- Student Profile—On the General tab. the Email field has been renamed Student Email. (E13436)
- "I Want To" Menu— View Student Absence Intervention has been added to the options.
- Student Absence Intervention—School Year context option and Last Attendance Calculation stamp added. See page 2 for additional information.
- Civil Rights Reporting—CRR download updated and now available. See page 2 for additional information.
- Help Documents— User interface has been redesigned for this release. You can now access the documents directly via this URL: http://webhelp.progressbook.com
- Transcripts (R702) Attendance hours can now be included on transcripts for the 2017-2018 and 2018-2019 school years.
- Transcripts (R702) EOC scores will now display on the transcripts with the calendar year, rather than the fiscal year. (E12190)
- Assessment Imports—The OST import has been updated to support current layouts for Next Generation, End of Course, and Alternate (AASCD) Assessment scores.

Notable Current Defect:

The R309A and R309B reports in StudentInformation are presently affected by a significant defect:

2017—2018 Civil Rights Data Collection (CRDC)

The Civil Rights Data Collection period is now open. The data is to be collected from the 2017—2018 school year.

Updates to the Civil Rights Report (CRR) and Manual Civil Rights Data Entry screens were included in the 18.8 release. These tools are now available in StudentInformation. StudentInformation > SIS > School > Civil Rights Reporting (CRDC)

In previous years, the CRR was split into two parts, but all parts have now been combined for one report. The data entered manually will combine with existing SIS data to populate the CRR. Additional information about Civil Rights Reporting can be found in the Student and Registration User Guide, which you can access HERE.

Student Absence Intervention

The Student Absence Intervention screens now include the following enhancements:

(E13878) - Last Attendance Calculation date and time stamp in upper left.

Last Attendance Calculation - 03/06/2019 09:00 PM

(E13841) - School year in context displays in Absence Hours Header; Data-not-available message for years prior to 2017-2018.





Attendance Hours on Transcripts

The custom format your building uses in the R702 (Transcript Formatter) can be updated for Attendance Hours to display for the 2017–2018 and 2018–2019 school years ONLY. Attendance for earlier school years can only display as Days. You may choose to have both display boxes on your transcript, and the images below provide an example of how they each appear.


