## **18.2 Updates in StudentInformation**

(Release Notes)

#### Enhancements:

- ⇒ Improved criteria selection process for Ad-Hoc Reports (Analytics Hub). \* New\* Preschool ELA Pre-ID export
- $\Rightarrow$  R309-B has been updated to display Partial Absence values.
  - ⇒ You now have the option of choosing either Days or Hours in the Report Format filed. When you select Days, the report displays both Days Absent and Partial Absence values. When you select Hours, the report displays Hours Absent values.
- $\Rightarrow$  Student Email Import screen/functionality added.

#### Resolved Issues:

- ⇒ The Daily Absence List will now correctly display absences for Sub-Calendar attending days when the days are listed as non-attending on the Master Calendar.
- ⇒ When choosing Daily Absences from the drop-down list in Shared Student Data, you will no longer see previous year's data when a student does not have any absences in the current school year.
- $\Rightarrow$  Some users were experiencing errors when processing student transfers between schools who do not share an ITC.
- ⇒ The Student's School Absences screen will now correctly display absences for days when the sub-calendar reflects an attending day and the master calendar show a non-attending day. This same issue is also resolved on the R307 report.



## SpS Updates in 18.2

- ◊ For creating new tasks, only Ohio Revised Forms are available.
- Wording on most forms now updated in compliance with ODE standards.

Notifications in StudentInformation

If you came to one of our Beginning of the Year sessions, you may have gotten a preview of the new Notifications feature in StudentInformation. You have also probably noticed the new icon in the upper right of your screen. Clicking here provides a list of the 15 most recent notifications you are subscribed to receive, as well as links to the new Notifications menu.



Notifications can be used at the district or building level, and administrators can configure the alert settings to be required or optional. Admins may also disable alerts.

Subscriptions to optional alerts can be maintained by individual users, but the proper security settings are required to utilize this feature. Presently the categories for notifications include: Custody Alerts, Discipline Incidents, Discipline Referrals, Medical Alerts, and Quiz Submitted.
