HISTORY

- Formed as part of Ohio Education Computer Network (OECN) – 1979
 - Ohio Revised Code 3301.075
- Cooperatives formed under Joint school building projects
 - Ohio Revised Code 3313.92
- ITC Scope and Definitions
 - Ohio Administrative Code
 - 3301-3 Data Acquisition Sites
- “A” site to provide services to “C” sites
 - Renamed ITC (Information Technology Center)

OHIO REVISED CODE 3301.075

- Ohio Education Computer Network
 - State BOE will adopt rules for acquisition of IT equipment and services
 - No more than 27 ITC's
 - Currently 18

OHIO REVISED CODE 3313.92

- Joint School Building Projects
 - Two or more districts may enter agreements including participation in OECN
 - Ohio Education Computer Network
 - K-12 Network
 - OARnet
 - Agreement needed to perform various activities
 - By-Laws
 - Membership
 - Board Members
 - Staffing
 - Fees

 - Treasurer – Sr. Member of Fiscal Staff

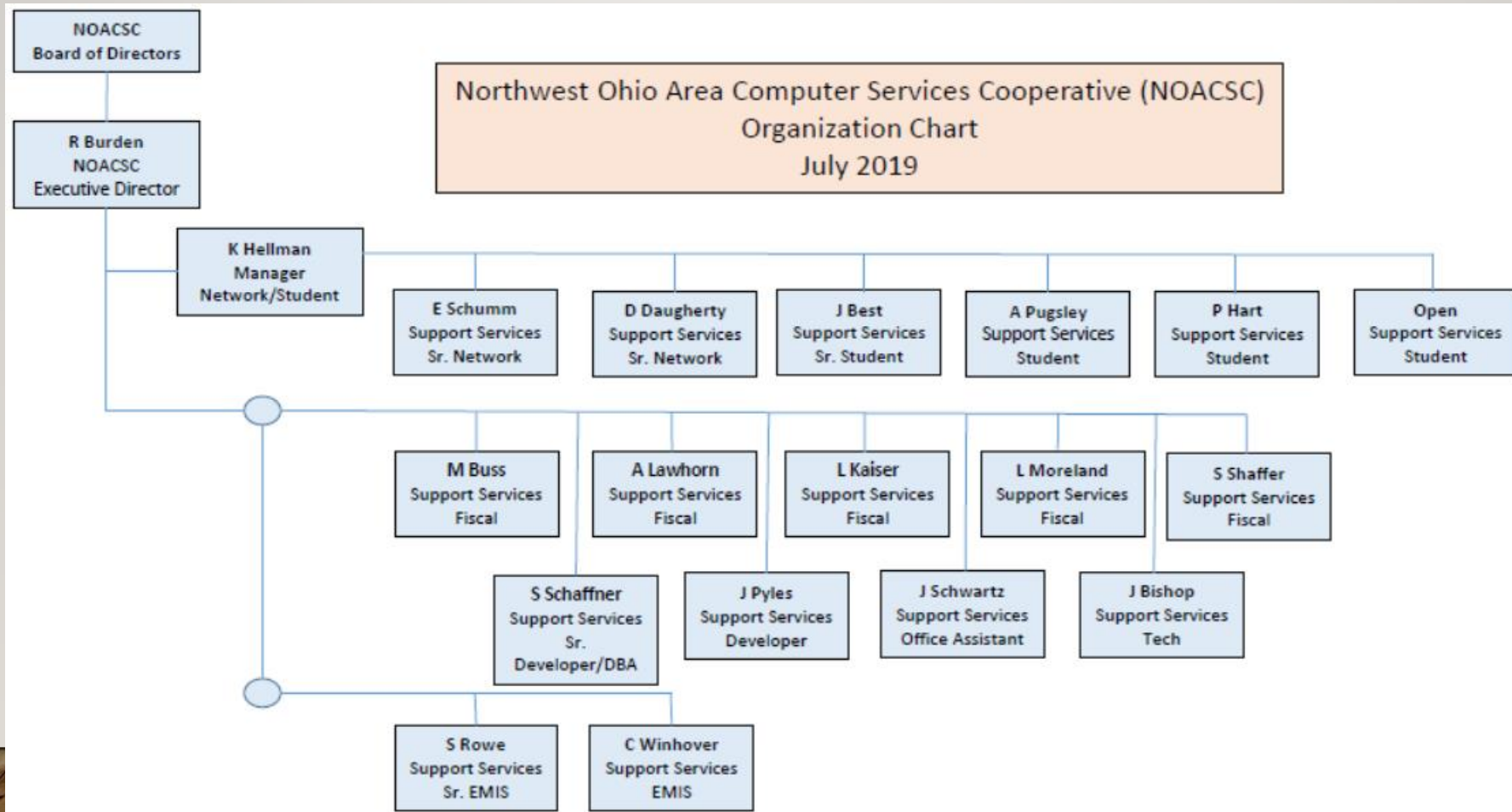

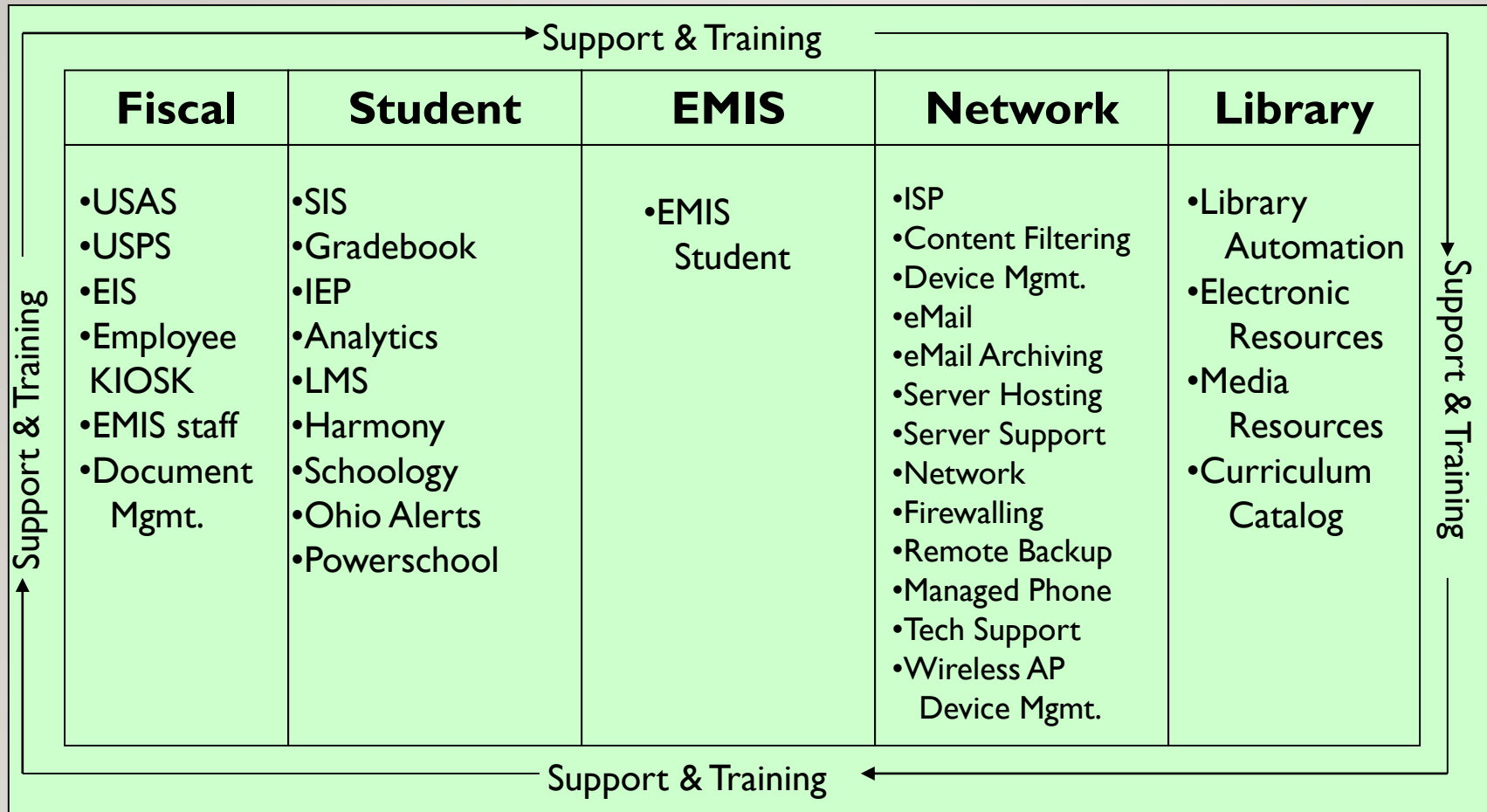
